4. Finance and Budget

4.1 Financial Review Part 1

The Council received a Financial Review Part 1 report for the period ended 30 June 2024 from the Chief Financial Officer and

NOTED

the operating surplus for the period ended 30 June 2024 was \$104.7 million, which was \$16.3 million higher than the budgeted surplus of \$88.5 million. Mr Trott commented on the positive variance.

The Council sought clarification from management on the student occupancy rates, on the internal grant funding for Shared Services (part of divisional operating contribution summary) and on term liabilities (including bank loans both long and short term). Management reported that accommodation occupancy rates were 96%; and commented on the accounting treatment of term liabilities and the internal grant funding as presented in the report.

5. Capital Development

5.1 Minutes

The Council received Part 1 of the Minutes of the meeting of the Capital and Development Committee held on 2 July 2024.

The Council sought clarification from management on the Terms of Reference and that of the composition and membership. Management confirmed that the Capital Development Committee is composed of the Chancellor, Vice-Chancellor, 3-4 members of the Council, 3 members of the Academic Staff (appointed after consultation with Pro-Vice-Chancellors) and the Chief Operation Officer. Those in attendance include the Chief Financial Officer, Director, Property and Campus Development, Chief Digital Officer, Head of Transformation and Improvement Officer, Head of Enterprise Project Management Officer and the Head of Campus Development.

6. Audit and Risk

6.1 Minutes

The Council received Part 1 of the Minutes of the meeting of the Audit and Risk Committee held on 18 June 2024.

8. Vice-Chancellor's Business

8.1 Vice-Chancellor's Report

The Council received a report from the Vice-Chancellor, dated 6 August 2024 covering topical issues, divisional updates, volunteering and social impact, upcoming events, awards, and recognition.

The Vice-Chancellor provided commentary on the Health Research Council Grants received in the latest HRC Projects and Programmes funding rounds (worth \$12.2 million), the University's Research Committee awarded 14 Research Themes (totalling \$1.4 million over four years from 2025-2028), recent achievements of alumni and support staff, and Divisional updates.

Given Professor J Ruru's absence at the last meeting, he also acknowledged her achievements in person.

9. Division of Sciences | Te Rohe ā Ahikāroa

Professors R Barker was welcomed to the meeting.

Professor Barker provided an overview of the Division of Sciences organisational structure including: staff FTE and student EFTS, the curriculum offerings and initiatives being implemented including interdisciplinary and cross University programmes, financial performance, outreach programmes such as Science Wānanga, Science Academy and the Marine Studies Centres, reductions and mergers, space utilisation, research and development achievements, staff updates and other strategic initiatives being undertaken which align with Pae Tata. He also discussed the work being undertaken to look at consolidating academic programmes including the possibility in forming a School of Earth and Ocean Science (Geology and Marine Science).

The Council discussed the student demographics in sciences and the value proposition of new initiatives whilst educating scientists of the future that will be equipped to play their part in the societal challenges we face today.

Re New and Amended Award proposals

Preamble

The recommendation of the Senate is sought for the following new prizes and new scholarship to proceed to the University Council for its consideration.

Please also note that the Scholarships and Prizes Committee has approved an amended prize.

1. NEW PRIZES

a) Consulting Surveyors of New Zealand Prize (300-level)

• **Department:** School of Surveying

• Value: \$1,000

- **Background:** This new prize is the second of two Surveying prizes sponsored by Consulting Surveyors of New Zealand (CSNZ). The prize makes official an existing departmental award, which recognises excellence in the study of law and policy relating to property rights, boundary law and title to land in New Zealand. Valued at \$1,000, this prize will be awarded to the student with the highest standard of achievement in the paper SURV306 Land Tenure 2. It also compliments the established Consulting Surveyors of New Zealand Prize (400-level), created in 1998 to recognise achievement in the study of professional practice and management in surveying in New Zealand.

Proposed Regulations

Consulting Surveyors of New Zealand Prize (300-level)

Established by the University of Otago in 2024 through a generous donation from Consulting Surveyors of New Zealand (CSNZ). This prize recognises excellence in the 300-level study of law and policy relating to property rights, boundary law and title to land in New Zealand, and replaces the existing (unofficial) departmental prize awarded annually for the same purpose.

The prize will be awarded annually by the University Council on the recommendation of the Pro-Vice-Chancellor (Sciences), after consultation with the Dean of the School of Surveying, to the student with the highest standard of achievement in the paper SURV306 Land Tenure 2.

The value of the prize will normally be \$1,000.

b) Hutton Prize for Excellence in O&G 5th Year

- **Department:** Obstetrics, Gynaecology and Women's Health (Wellington)
- Value: \$500
- **Background:** This award formalises the Hutton Prize for Excellence in O&G 5th Year, a recently-created departmental prize that rewards the top fifth-year MB ChB student in Obstetrics and Gynaecology (O&G) at the University of Otago Wellington, based on their performance in internal O&G assessments. The prize is the initiative of sponsor Honorary Professor John Hutton ONZM, who had a lengthy and distinguished teaching career in O&G at the University of Otago Wellington between 1983 and 2021.

Proposed Regulations

Hutton Prize for Excellence in O&G 5th Year

Formally established by the University of Otago in 2024 through a generous donation from Professor John Hutton ONZM, this prize recognises the top fifth-year MB ChB student in Obstetrics and Gynaecology at the University of Otago, Wellington.

Professor Hutton, a graduate of Otago Medical School, enjoyed a long and distinguished teaching career at the University of Otago, Wellington, from his appointment as Professor of Obstetrics and Gynaecology in 1983 through to his retirement in 2021. In 2022, he was made an Officer of the New Zealand Order of Merit (ONZM) for his services to obstetric and gynaecology education.

The prize will be awarded annually by the University Council, on the recommendation of the Head of Department of Obstetrics, Gynaecology and Women's Health (Wellington), to the highest achieving student in Obstetrics and Gynaecology in Year 5 of the MB ChB programme at the University of Otago, Wellington.

The value of the prize will normally be \$500.

2. NEW SCHOLARSHIP

c) Honours Scholarship for Excellence in Neuroscience

- **Department:** Neuroscience Programme, School of Biomedical Sciences
- Value: \$6,000
- **Background:** This new scholarship rewards excellence in Neuroscience by offering financial support to outstanding students during their BSc Honours

studies. The scholarship is internally funded, and replaces the Neuroscience Programme Summer Research Scholarship. It will be awarded annually to the student with the highest GPA across five 300-level papers, being their best four Neuroscience major papers and best extra paper. The recipient will be selected by the Board of Studies for Neuroscience in December, from all applicants for admission to the BSc(Hons) in Neuroscience programme.

Proposed Regulations

Honours Scholarship for Excellence in Neuroscience

Established in 2024 by the University of Otago, this scholarship aims to reward excellence in Neuroscience and provide financial support to outstanding students during their BSc Honours studies. It replaces the Neuroscience Programme Summer Research Scholarship.

Eligibility

Candidates must:

- have completed a BSc degree with a major in Neuroscience at the University of Otago
- have applied for admission to the BSc(Hons) programme in Neuroscience.

Application Process

No application is required. A nominee will be selected directly by the Board of Studies for Neuroscience in December from the pool of students applying for admission to the BSc(Hons) programme, and an offer letter will be sent to the nominee for acceptance. The scholarship will be presented to the recipient by the Director of the Neuroscience Programme at the end of year awards ceremony.

Selection Process

- The scholarship will be awarded to the student with the highest GPA (grade point average) across five 300-level papers (best four papers counting towards a Neuroscience major and best extra paper).
- If two or more candidates have the same GPA, other 100-300 level papers may be assessed.

Financial

- The total value of the scholarship is \$6,000 for one academic year, with full-time tenure.
- The scholarship will be paid as a monthly stipend from 1 February to 31 October in the year of tenure.

Tenure

• The scholarship shall be held with full-time tenure.

- The scholarship must be taken up in the year following the granting of the scholarship.
- The scholarship may be held concurrently with any other University of Otago scholarship where its regulations also allow co-tenure.
- The recipient must achieve at least a B+ average (GPA 6) in Semester 1 of the Honours year to retain the scholarship in Semester 2.

Other Requirements

- Award of the scholarship is dependent on the recipient being admitted to the University of Otago.
- The University of Otago reserves the right to use the names, photographs, and details
 of successful candidates for advertising and publicity. The award holders must agree
 to be reasonably available to participate in interviews and promotional activities if
 requested by the University of Otago.
- This scholarship may be terminated if the recipient brings the University into disrepute.

3. AMENDED PRIZE

d) Consulting Surveyors of New Zealand Prize (400-level)

• **Department:** School of Surveying

• Value: \$1,500

- **Background:** This prize was created in 1998 to recognise excellence in the study of professional practice and management in surveying in New Zealand. Funded by Consulting Surveyors of New Zealand (CSNZ), the prize goes to the highest achieving student each year in the paper SURV450. The purpose of this amendment is threefold: (1) to change the title from Consulting Surveyors of New Zealand Prize to Consulting Surveyors of New Zealand Prize (400-level); (2) to change the name of the paper for which the prize is awarded from SURV450 Professional Studies to SURV450 Professional Practice; and (3) to state the monetary value of the prize in the body of the regulations.

Current Regulations

Consulting Surveyors of New Zealand Prize

Established in 1998 by the Consulting Surveyors of New Zealand.

The prize is awarded by the University Council on the recommendation of the Pro Vice-Chancellor (Sciences), after consultation with the Dean of the School of Surveying to the student who attains the highest standard of achievement in the paper SURV 450 Professional Studies.

Proposed Regulations

Consulting Surveyors of New Zealand Prize (400-level)

Established by the University of Otago in 1998 through a generous donation from Consulting Surveyors of New Zealand (CSNZ), this prize recognises excellence in the 400-level study of professional practice and management in surveying in New Zealand.

The prize is awarded <u>annually</u> by the University Council on the recommendation of the Pro-Vice-Chancellor (Sciences), after consultation with the Dean of the School of Surveying, to the student <u>with</u> the highest standard of achievement in the paper SURV450 Professional <u>Practice</u>.

The value of the prize will normally be \$1,500.

Topical Issues

Matariki Network Meeting and Alumni Engagement

The Vice Chancellor is overseas for the first two weeks of September attending a meeting of the Executive of the Matariki Network of Universities in Uppsala in Sweden and meeting alumni and other stakeholders in Sweden and the UK. The Matrariki Network meeting has a particular focus on indigenous issues, and the DVC Maori Distinguished Professor Jacinta Ruru will also be at the meeting. Following from that meeting, we will be hosting alumni events in Stockholm, London, Oxford, Cambridge and Edinburgh. In Edinburgh the Vice-Chancellor will represent Dunedin City at the 50th anniversary of Dunedin/Edinburgh sister city relations.

Launch of the Māori Strategic Framework

An event was held on the 30th of August to launch Te Aka Matua 2030/The Maori Strategic Framework 2030, organised by the Office of Māori Development and the Deputy Vice-Chancellor Māori office. At the event there was a panel discussion of SLT members talking about how they will be progressing their work in line with the Framwork. The event also included performances by Kaimahi Rōpū Waiata, the staff waiata group.

James and Jean Davis Prestige Visitorship
