The following medals and awards are being offered in 2025 by the Royal Society Te Apārangi. Full details about the medals and awards can be found here

Rutherford Medal – for preeminent research, scholarship, or innovation by a person, or team, in any field of engineering, humanities, mathematics, sciences, social sciences, or technology

Te Rangaunua Hiranga Māori Award – for excellent and innovative research co-created by Māori, that has made a distinctive contribution to community wellbeing and development in Aotearoa New Zealand

Awards are also offered in the following categories:

- Communication, Leadership and Application
- Early Career Researcher Awards
- Humanities and Social Sciences
- Physical and Biological Sciences
- Technology and Applied sciences, and
- Other research funds and opportunities (comprising named funding grants/awards).

The closing date for nominations and applications is Monday, 31 March 2025.

As in the past, the Society's Academy is keen to receive nominations from under-represented groups, particularly with respect to gender, ethnicity and employment context.

- <u>Charles Fleming Senior Scientist Award</u> an annual research grant worth up to \$10,000 to support the research of a senior scientist in New Zealand.
- <u>Charles Fleming Publishing Award</u> an annual award worth up to \$8,000 to support the preparation
 of scientific books and relevant publications.
- Hutton Fund Funding of \$1,000 for research in New Zealand zoology, botany and geology.
- <u>Skinner Fund</u> Funding of \$1,000 for research in the study of the history, art, culture, physical and social anthropology of Māori and Polynesian peoples

A new Research Administration System is on its way to manage externally contracted projects- updated

A new Research Administration System to manage externally contracted projects is now live

The University's new Research Administration System (RAS) is a database and approvals mechanism designed for intuitive, efficient research administration. In time, it will replace (amongst other things) the use of Costing and Consents Worksheets (CCWs) for budgeting.

What you need to know

RAS is being implemented in two phases. It is now live for the following first-phase users:

- Senior Research Administrators
- Research Advisers
- Business Development Managers
- Research Finance Associates and Finance Associates
- Those with responsibility for funding application approvals (e.g. HoDs, Deans, PVCs)

The way in which these RAS users manage research administration is changing, but their roles are not, so you can continue to seek advice as you would normally, but please be patient while they navigate the new system.

RAS will be available to researchers as soon as possible, with preparations under way for training and familiarisation in the coming weeks . Until then, please note that the Costings and Consents Worksheet (CCW) has been amended for use during the first phase of go-live. To access the amended CCW, follow this link. This will require the Principal Investigator to sign the CCW, but all other approvals will happen via RAS.

FoR and SeO codes must be entered in the relevant section of the CCW. A full list of the codes is included in the electronic version of the ccw. If this information is not provided R&E won't be able to enter your project into the system. Please talk to your Research Advisor or Business Development Manager if you have any queries regarding these.

Changes to the 2025 Health Research Council Health Delivery round - Updated

The HRC's Health Delivery funding round is the primary investment mechanism focused on supporting research that directly informs health policy, practice, or systems. Up until now, **Health Delivery Research Career Development Awards** have been offered twice a year. From 2025 onwards, however, HRC will bring these awards in line with all their other grant types and **offer them once a year**.

MBIE – Catalyst: New Zealand – Singapore Leveraging AI for Healthy Ageing 2025

Proposals are invited for New Zealand research organisations to work with Singapore research organisations to develop health related Artificial Intelligence (AI) solutions to support healthcare providers to deliver better health outcomes.

New Zealand and Singapore applicants must jointly develop a single proposal using the proposal template provided on the AISG website and submitted in the AISG Grant Management System (GMS) portal. The New Zealand project team is required to confirm they have the agreement of their host institution before submitting their proposal. 2025 AINSE Research and Education Opportunities – Updated

AINSE Pathway Scholarship: Eligible students enrolled in an Honours degree (final year) OR a Masters Degree, at an AINSE Member University, for some period between 1st January 2025 and 31st March 2025 can apply. The student's research project must involve the use of ANSTO facilities, or the analysis of data previously collected from ANSTO facilities, in collaboration with an ANSTO staff member. Applications close 15 March 2025.

<u>AINSE Postgraduate Research Award (PGRA)</u> - <u>NEW</u>: Eligible students from AINSE Member institutions who are enrolled in a PhD and receiving an RTP scholarship or equivalent can now apply. The research project must require the use of ANSTO's facilities and expertise. Applications close 15 April 2025

AINSE Residential Student Scholarship (RSS) - NEW: For PhD students who need to stay at ANSTO facilities for a period averaging no less than 6 moths per year. GENERAL INFORMATION REGARDING RESEARCH FUNDING AT OTAGO

When you need to contact us

Staff are reminded that every application for external research funding must come through Research and Enterprise, via your Research Advisor. If you are not sure, please call and we will be able to advise you. All grant applications and proposals should be submitted by academic staff. Please inform your Research Advisor if you intend to apply as Principal Investigator for *any* contestable funding, whether advertised here or not, at the beginning of the development of your application. The same situation exists if you have been approached by researchers at another institution/organisation to collaborate on a funding proposal where Otago is not the lead institution and/or is not submitting the proposal.

Costings and Consents Worksheet – Please use the latest version on website

A UoO Costings and Consents Worksheet (CCW) is required for all applications, Later in 2025, RAS will be available to researchers. Until then, please note that the Costings and Consents Worksheet (CCW) **should still be completed by the PI**, **but** has been amended for use during the first phase of go-live. To access the **amended** CCW, follow this link. This will require the Principal Investigator to sign the CCW, but all other approvals will happen via RAS. For advice on the use of the CCW to develop costings for your project, please contact your Research Advisor.

Requirement for Field of Research (FOR) and Socio-Economic Objective (SEO) codes

It is now a requirement that Universities report to the Ministry of Business, Innovation and Employment on FOR and SEO codes for all research and commercial projects. These codes must be entered in the relevant section of the costing and consent worksheet. A maximum of three codes can be selected for each category and percentages should be in blocks of 10. A full list of the codes is included in the electronic version of the ccw. If this information is not provided R&E won't be able to enter your project into the system. Please talk to your Research Advisor or Business Development Manager if you have any queries regarding these.

The **UoO Policy Document on Externally Funded Research**, which outlines both the need for and the usage of the CCW, can be viewed <u>here</u>.

Panui Rangahau Māori – Māori Research Consultation

This message clarifies that The Ngāi Tahu Research Consultation Committee is not being disestablished. The University is providing new roles alongside existing support through the Research and Enterprise Office which will support researchers in developing your research ideas.

As many may be aware the Ngāi Tahu Research Consultation Committee (NTRCC) is experiencing significant delay due to continuing support staff shortages. Unfortunately, this has yet to be resolved.

The recommended course of action for researchers is to continue to submit to NTRCC as usual. Working within your divisions and department, work with your <u>Research Advisors</u> (who are there to help) to develop your Vision Mātauranga Policy statements and progress developing your ideas toward ethics approval. Document your thoughts regarding VM, relevance to Māori, and pathways to impact on society, this is all valuable thinking even in early stages.

Your Research Advisors will be able to provide support in the first instance or may choose to escalate if necessary.

Please note for Christchurch researchers the Māori Health Advancement Programme for researchers at UOC has two components:

- a professional development programme and
- a new research review process

Ethics and Regulatory Consents

The University requires that any research involving human participants and/or animals is conducted in accordance with the highest ethical standards. Where appropriate, compliance includes ethical approval from the relevant ethics committee. Please refer to our Ethics and Regulatory Consents webpage for further information.

Human Ethics applications and assessment via Conduit

All applications for Human Ethics consents and amendments (Health, Minimal Risk Health Research (MRHR), Category A Non-Health, Category B Low Risk Non-Health) must now be made via Conduit. This system replaces all previous methods of applying for Human Ethical consents. Note that applications for Animal Use protocols will remain via IARMS.

Checklist for submitting grant proposals

Remember to include:

- Copy of the application (signed by applicant, and HoD/Dean if requested by funder)
- University of Otago Costing & Consents Worksheet (CCW) (signed by applicant)
- Evidence of Māori Research Consultation
- Ethical / Regulatory approvals (if required and already approved)

Research and Enterprise then obtains the authorised signature of the University for you (if required), copies the application, and sends it to the funding body by the due date.

Extension and Closure of Research Accounts – Notice to all Departments

Extensions - All requests for an extension should be done before the end date of the contract. Researchers will need to contact their Research Advisor or Business Development Manager in the first instance. This process replaces all previous notifications by Research and Enterprise. <u>Closures</u> — Closure processing will now occur in RAS, with the Research Finance team initiating this process. Research Finance will action any journals for surpluses or deficits and organise credit notes for the return of surplus funds where applicable.
